STANDARDISED PRICELIST

All funeral directors are legally required to publish this price list for a standardised set of products and services. This is to help you think through your options and make choices, and to let you compare prices between different funeral directors (because prices can vary).

ATTENDED FUNERAL (funeral director's charges only)

£2835

This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.

Taking care of all necessary legal and administrative arrangements

£1450

Collecting and transporting the deceased person from the place of death (within a 30 miles radius of our premises) into our care

£200

Care of the deceased person before the funeral in appropriate facilities. The deceased will be kept at Tom Ross and Sons, Orchard Road, Forres, IV36 1PJ or at a branch of your choosing

Providing a suitable coffin – This will be made from an oak veneer

Viewing of the deceased person for family and friends, by appointment with the funeral director

**By law a fee is listed but we do not charge for viewings*

At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (within 30 miles of our premises) in a hearse or other appropriate vehicle

UNATTENDED FUNERAL

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

Burial (funeral directors charges only)

Cremation (funeral director's charges plus cremation fee at Moray Crematorium)

The funeral director can give you a full list of what they can supply. They are likely to charge for these additional products and services, so you may choose to take care of some arrangements without their involvement, or you can use a different supplier.

¹ This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

² In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.

TERMS OF BUSINESS

We may require upfront payment of the value of the third-party costs no less than 72 hours prior to the funeral. The final invoice will be issued approximately 2 weeks after the funeral takes place with any outstanding balance due within 28 days unless otherwise agreed by us in writing.

If the balance has failed to be paid in full by the due date, we may charge you interest;

- At a rate of 4% above our banks base rate from time to time of enforce
- Calculated from the date of our invoice until payment received
- Compounded on the first day of each month; and
- Before and after any judgement (unless a court orders otherwise)

We may recover the cost of taking legal action to recover unpaid invoices.
